### Local Government Ordinary Election Close of Enrolments Shire of Dalwallinu Roll Close: 5:00pm Friday, 22 August 2025

You may be eligible to be enrolled to vote in the local government elections on 18 October 2025 if you live in or are an owner or occupier of rateable property in the Shire of Dalwallinu.

### **Residents**

You are automatically enrolled to vote if you are on the State Electoral Roll as at 5:00pm Friday, 22 August 2025. If you are not already on the State Electoral Roll and meet the eligibility criteria, or if you have changed address recently, you must complete and submit an enrolment form.

You can enrol or update your details online, or download an enrolment form, via the Western Australian Electoral Commission website (<a href="www.elections.wa.gov.au/enrol">www.elections.wa.gov.au/enrol</a>). Forms are also available from the Australian Electoral Commission (<a href="www.aec.gov.au">www.aec.gov.au</a>). Enrolments and updates must be completed and received by 5:00pm Friday, 22 August 2025.

### **Non-Resident Owners and Occupiers**

If you are a non-resident owner or occupier of rateable property in the Shire of Dalwallinu and are on the State or Commonwealth Electoral Roll, you may be eligible to enrol to vote by lodging an enrolment eligibility claim with the Shire of Dalwallinu.

If a rateable property is owned or occupied by more than two people, a majority of the owners/occupiers may nominate two persons from amongst themselves who are on either the State or Commonwealth Electoral Roll, to enrol as owner/occupier electors.

A body corporate that owns or occupies rateable property may nominate two employees or officers who are on either the State or Commonwealth Electoral Roll to enrol as owner/occupier electors.

If you are **not** on the State or Commonwealth Electoral Roll and own or occupy rateable property in the Shire of Dalwallinu, were on the last electoral roll for the Shire of Dalwallinu prior to May 1996, and are already enrolled, you continue to retain that status until your enrolment would have otherwise ended.

Contact the Shire of Dalwallinu for an enrolment eligibility claim form, to confirm whether you are already enrolled, or for further information.

An eligibility claim must be lodged with the Chief Executive Officer by 5.00pm Friday, 22 August 2025.

The Annual Budget was adopted by Council at a Special Council Meeting held on 15 July 2025.

The 2025-2026 budget is another budget packed with projects.

They include \$6.9M on roads, \$1.1M on Land & Buildings, \$1.6M on Other Infrastructure, \$563K on Plant & Equipment and \$1.44M transferred to Reserves.

Thank you to the community members who took part in our recent survey regarding the colour choice for repainting the Dalwallinu Town Hall.

140 responses were received with 76% voting for the colour to remain the same as the existing colour. The closing date for the Request for Quote to repair and repaint the hall is Wednesday 13 August 2025.


Our Shire is proud to have been one of the 75 RoadWise Councils recognised during the night and we are excited to continue working towards better practice road safety for our communities.

### **Special Council Meeting**

On 15 July 2025 Council adopted the 2025-2026 budget. Despite many costs increasing due to governance protocols such as audit costs increasing 5-fold, extra persons required for committees,

software updates needed as greater scrutiny is placed on the shire business, a responsible rate increase of 3.5% was applied. This only tracks the CPI and if we didn't increase by this amount, we would soon be in a difficult position. A lot of the credit for this sensible rate increase is down to the shire Senior Management staff bringing in the 2024-2025 year on budget and working hard to get the costings right for the coming financial year.

I praise their efforts and are very thankful not to be one of the Shires hitting the headlines.

### **Last Month's Newsletter**

In last month's newsletter I wrote a piece on driving safely and with caution. The article was written with no knowledge of the accident that occurred on Pithara East Road. A very unfortunate accident which only highlights what a moment lacking concentration or overconfidence can result in.

### **Rabbit Proof Fence Rd HV Rating**

I just want to let people know that the Heavy Vehicle section of Main Roads is doing an assessment of the suitability of the sealed section of the Rabbit Proof Fence Road to have a RAV 10 rating. The Shire is not happy with this rating and has been trying to get it reduced for a decade or more. The safety factor when passing other vehicles and school buses plus the pavement damage is a real concern to us. Council will keep everybody informed on this matter.



### Are you a Responsible Pet Owner?

The Cat laws are about encouraging responsible pet ownership and reducing the number of unwanted cats in the community and the number that are euthanised each year. All cats that have reached six months of age are required by law to be:



- micro-chipped
- sterilised; and
- registered with the Shire

Under The Dog Act 1976 and regulations, any dog over the age of 3 months should be registered within the Shire. All dogs need to be micro-chipped. Proof of micro-chipping is required at time of registration.

Dog and Cat Registrations

Due 31 October annually

Please be a responsible owner and secure your animals by registration. Legislation applies to Cats after six months of age and Dogs after 3 months. Registrations are due on 31 October each year.

Please don't risk losing your precious pets by not having them registered. Call into the Shire and make sure your animals are safe.

**Moderate:** Plan and Prepare.

**High:** Be ready to act.

**Extreme:** Take action now to protect your life and property.

Catastrophic: For your survival, leave the bushfire risk areas.



### **Be Aware and Prepare**

Where there is minimal risk, Fire Danger Ratings will be set to 'No Rating". On these days you still need to remain alert and abide by local seasonal laws and regulations.



### Do you need to update your details with the Shire?

### **Emailing Rates Notices**

You can elect to have your Rates Notice issued via email. This service currently does not extend to Instalment Reminders. To register for this option you need to be a ratepayer on the assessment and put your request in writing. You can apply online through the Shire website <a href="https://www.dalwallinu.wa.gov.au/contact-us/erates-registration.aspx">https://www.dalwallinu.wa.gov.au/contact-us/erates-registration.aspx</a> or by completing a Change of Address form which can obtained from the Administration office. If you own properties in multiple names a separate form is required for each individual/company Notices can only be sent to one nominated email for each assessment and you will not receive a paper notice if this option is selected. You still need to keep your residential and postal addresses up to date.

### **Mailing Address not Correct?**

It is your responsibility to advise the Shire in writing of any changes of address. Incorrect addresses may cause unnecessary delays in the delivery of your rates notice. Change of addresses must be made in writing by the ratepayer/s. An online form is available on the Shire website <a href="https://www.dalwallinu.wa.gov.au/contact-us/change-of-details.aspx">https://www.dalwallinu.wa.gov.au/contact-us/change-of-details.aspx</a> or by contacting our Customer Services team.

### **Pensioner/Senior Rebate**

If you are an eligible\* pensioner or senior card holder who does not currently claim the rebate, you can apply through the Water Corporation, even if you are not a Water Corporation customer. The Shire are unable to receive applications direct from pensioners or seniors, applications must be made to Water Corporation.

This is effective for both Local Government and Water rates. If you do not have access to the internet please bring your concession card to the Shire Office and we will help you apply for the concession. Unsure if you already claim the concession on your property within the Shire of Dalwallinu? If you are already claiming the concession you will have the line "State Government Rebate Allowed" on your Rates Notice. Your rates MUST be paid in full prior to 30 June 2026 to receive the rebate.
