The written down value in the Shire's financial records as at June 2021 is as follows:

It is to be noted that since these valuations, the lot has increased in size from 1,012^{m2} to 1,477^{m2} due to amalgamation of the rear of 2 Dungey Road.

An independent market valuation was undertaken by McGees property on 9 November 2021 and the valuation provided by them for Lot 360 (1) Wasley Street, Dalwallinu was \$190,000. This is well below that the Officer considers an acceptable price.

Lot 1 Bell Street sold in February 2021 for \$94,000. Lot 1 was 1,073m² which equates to \$87.60 per square metre. Lot 360 Wasley Street is 1,477m² which equates to \$129,385 for the land value alone.

2. Decline the offer received from B & BP Southcott of \$290,000;

Each year on Australia Day, the Community Citizen of the Year Awards give local governments around the state the opportunity to acknowledge the contribution and celebrate community engagement of people within the community.

Nominations for the Australia Day Community Citizen of the year award were open until 31 October 2021.

The nomination for Mrs Joy Wornes was received on 29 October 2021.

The nomination for Thomas Davis was received on 11 November 2021.

The Shire had been in communication with the Principal at the Dalwallinu District High School who had expressed their desire to nominate a Young Citizen of the Year. This process from the school took longer than anticipated. As this nomination could potentially be received outside of the closing date the Shire sought advice from Jenny Sophian, Auspire – Australia Day Council (WA). They advised the Shire that they would accept this nomination after the closing date. They wanted to encourage more nominations and given that we only had one Senior nomination to date they were supportive of the late nomination.

The Community Citizen of the year awards program has a number of key objectives which include:

- To engender community contribution and participation;
- To encourage community harmony and engagement at a local level;
- To showcase grass-roots community involvement, achievement and capacity-building initiatives.



There are four (4) awards categories:

- Community Citizen of the Year
- Community Citizen of the Year – Youth (*under 25 years of age and must be 16 years of age on 26/1/2022*)
- Community Citizen of the Year – Senior (*over 65 years of age*)
- Active Citizenship – group or event

Selection Guidelines

In choosing the recipients of the Community Citizen of the year Awards, regard is given to the nominee's achievements in the year immediately prior to receiving the award, as well as their past achievements and ongoing contribution to the community.

The recipient of the Community Citizen of the Year is to be judged to have met a number of criteria including:

- Significant contribution to building harmony and inclusion with the local community;
- Demonstrated leadership on a community issue resulting in the enhancement of community life;



- A significant initiative which has brought about positive change and added value to community life;
- Inspiring qualities as a role model for the community.

Eligibility Criteria

- Nominees should reside or work principally within the local authority making the award;
- Awards may be granted posthumously in recognition of recent achievements;
- Groups of people or couples will not normally be eligible except when meeting the criteria for a community group. Though a couple or pair working together on a joint initiative may be considered in an individual category at the discretion of the local selection committee;
- A person may receive an award on more than one occasion in recognition of their particularly outstanding community contribution or involvement in an alternative initiative;
- Unsuccessful nominees may be nominated in future years;
- Nominations must be apolitical in their nature and should not in any way bring the awards program or local government area into disrepute;
- Sitting members of State, Federal and Local Government are not eligible.

IN SUPPORT OF JOY WORNES

Joy has been a resident in the Dalwallinu district for over 60 years. Over that period of time she has volunteered her services to many organizations such as Music and Drama society, Wubin School Parents and Citizens Group, Dalwallinu Creative Arts Society, Dalwallinu Ag Society, Church Groups, CWA, Wubin Progress Association, Dalwallinu Tourism and in the last number of years has been a driving force in the establishment and running of the Wubin Wheatbin Museum.

In the 1960s it became known in the community that she had a love of music and played the piano and this led her to playing and being involved in many productions of Music and Drama Shows performed for the Dalwallinu Community. She also played for church services, weddings and funerals for over 40 years.

Although Joy had no formal teacher training, she began teaching the piano to individual students and was then approached to teach music in Wubin, Dalwallinu and Kalannie Schools. She inspired many of the students with her love of music and became widely known for this as her students achieved well in State recognized Music Examinations, performed in Music Eisteddfods throughout the wheatbelt and in Perth. Joy was always in demand, particularly at end of year school concerts. Concerts performed by the Wubin Primary School were known to pack the Wubin Hall each year.

Joy was a driving force behind a large number of projects completed by the CWA where she was a long-time member. She became involved in Dalwallinu and Districts Tourism and was one of the initiators of the famous "Wattle Week" which continues to this day and brings hundreds of tourists to the area for that particular week. She was involved in engaging a specialist from Perth to come to the Dalwallinu Shire to name all the species of Wattle in the district.

As part of promoting Tourism into the Dalwallinu Shire, Joy obtained a license to display many of the wildflower varieties growing in the district and with the help of her husband, Collin, prepared and displayed them in the Wubin Hall annually which was run in conjunction with Wattle Week. There could be over 200 plants on display which required continual monitoring. Some blooms only lasted one day and had to be picked fresh daily. Their love of plants led Joy and Collin to create a plant nursery, originally in Wubin before relocating it in later years to Dalwallinu.

With the explosion of the mining industry north of Dalwallinu the tourists started to visit. Dalwallinu became known as the "Gateway to the North" and visitors loved exploring and enjoying the native plants. With the Wreath Leschenaultia becoming a favourite amongst tourists Joy and Collin planted the cult flower at the Wubin Information Bay. With its red and black symbolic windmill and the success of the Wreath Leschenaultia it encouraged tourists to stop and take a break in town. This was indeed a special effort as the Wreath does not grow in many locations at all. Rumour has it that even Kings Park botanists struggled to successfully grow the wreath. This highlights the special care and attention Joy and Collin must have given the Wreaths to enable it to flourish for five years. Eventually and despite them being covered with rabbit netting the corellas managed to destroy them.

When the old Wubin Progress Association was reformed Joy became Secretary of the Association. She took to this position with great enthusiasm and energy and together with many volunteers managed to establish a fantastic museum in Wubin. Joy spent countless hours preparing grant applications and doing the hundreds of hours of administration required to establish what is now known as the Wubin Wheatbin Museum. The amount of work Joy undertook to ensure the success of this enterprise cannot be overlooked and Joy continues to be Secretary to this day. The Wheatbin museum has become a well-known tourist attraction in the region, opening during the wildflower season, with hundreds of visitors each year.

For her many contributions to this community we feel she is a worthy nominee.
