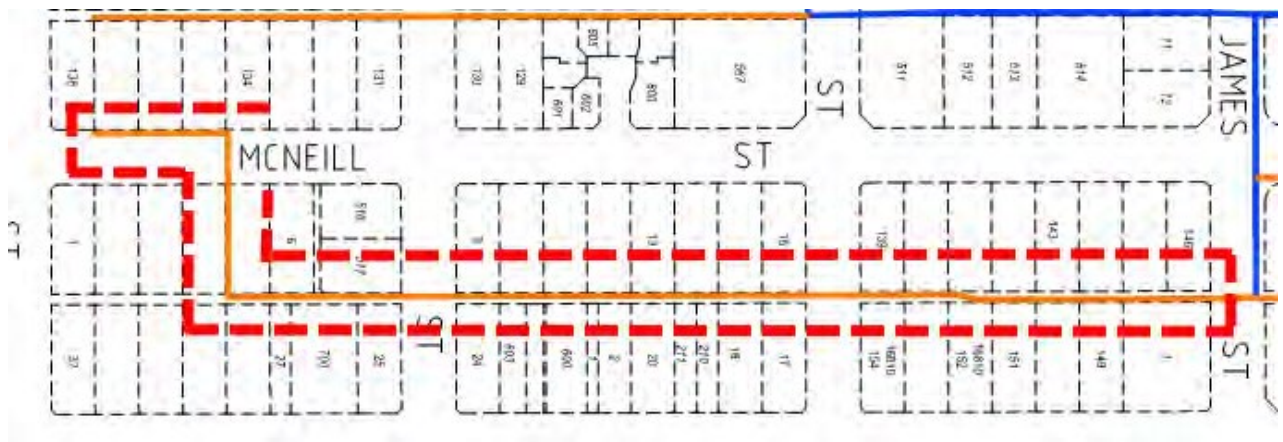
Council is requested to authorise the calling of tenders for the provision of the sewerage upgrades to McNeil Street and to set the tender qualitative criteria.

Purpose of Report

Council is requested to consider unbudgeted financial requests from the Kalannie Bowling Club and Kalannie Football Club for their respective sporting facilities.

Background

Kalannie Bowling Club

During the 2019-2020 budget deliberations the projects identified in the Shire of Dalwallinu Sport & Recreation Plan were presented to Council. One project that was identified for 19-20 was the new bowling greens for the Kalannie Bowling Club.

The Kalannie Bowling Greens Project was included in the 2019-2020 budget with a total cost of \$150,000 and offset revenue of \$100,000 to come from the Kalannie Bowling Club and any other external source. This allowed for a Council contribution of \$50,000 towards the project.

It is to be noted that this project is not eligible for CSRFF funding as the current greens were funded by that fund.

Correspondence from the Kalannie Bowling Club was sent to the Shire President on 23 September 2019 thanking Council for their \$50,000 contribution and advising that they have secured an additional \$5,000 from CBH, however they still had a shortfall of approximately \$25,000.

The correspondence is requesting Council to continue to support them with an additional \$25,000 to meet the cost of replacing the bowling greens.

Kalannie Football Club

Correspondence from the Kalannie Football Club was sent to the Chief Executive Officer on 2 October 2019 requesting a contribution from Council of \$18,000 towards the re-surfacing of the Kalannie netball court at a total cost of \$28,000. The Kalannie Football Club are prepared to contribute \$10,000 towards the project.

In February 2015 the Kalannie netball courts were resurfaced with a 'courtflex sports surface' at a cost of \$37,450. Unfortunately when this surface got wet it became slippery and dangerous. In 2016 when Kalannie hosted the grand final, the Central Wheatbelt Netball League moved that game to Dalwallinu due to the surface of the court being too slippery.

It is the Officer's understanding that the Kalannie Netball Club attempted to seek compensation through the Department of Consumer Protection (DCP). The DCP found in favour of the Kalannie Netball Club however the supplier refused to replace the surface or refund the cost. The DCP has no powers to enforce their findings. The only alternative was to go through the court system which was going to be too costly for the club.

In 2018 the Kalannie Netball Club removed the 'courtflex sports surface' and played on the cracked sub-standard surface that was underneath.

Officer Comment

Kalannie Bowling Club

Bowls is the major summer sport for both men and women in Kalannie and the current bowling greens in Kalannie are in need of replacement. The current Kalannie Bowling Club greens were installed in June 2007 at a cost of \$162,994.

Due to the extent of damage to the greens, the Kalannie Bowling Club had to play its Pennant bowls home games in Dalwallinu in the 2018-2019 season. The damaged greens can be seen in the attachments.

Kalannie Football Club

In 2020 the Kalannie Football Club is hosting a double header finals round which means two (2) games of football, netball and hockey followed by the league medal vote count at the town hall. Most of the works required to host this event can be undertaken by the Kalannie Football Club and the Shire works crew.

The surface of the netball court is the major item that requires action. The correspondence indicates the cost to resurface the court is approximately \$28,000 inc GST to which they are prepared to

contribute \$10,000 towards, leaving a shortfall of approximately \$18,000. The proposed new surface will have a fiberglass membrane to reduce reflective cracking.

It is to be noted that as per Council's Purchasing Policy 3.5, the resurfacing of the netball courts will require two (2) quotes and the replacement of the bowling green will require three (3) quotes unless the quotes are over \$150,000 therefore a tender is required to be called.

Given the value of these projects it is the Officer's recommendation that the projects be undertaken by the Shire of Dalwallinu and not the Clubs as these assets belong to the Shire and Council's purchasing policy needs to be adhered to.

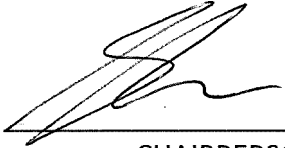
