#### **Purpose of Report**

Council is requested to endorse the final design documentation and costings for the upgrade to the Dalwallinu Recreation Centre.

#### **Background**

At the Ordinary Meeting of Council held 28 March 2017, Council resolved the following:

#### **'MOTION 8802**

Moved Cr KL Carter Seconded Cr NW Mills

That Council authorise the transfer from the Dalwallinu Recreation Centre Reserve for the unbudgeted expenditure of \$124,700 for the engagement of Site Architecture Studio to provide architectural services for the Dalwallinu Community Recreation Centre.

Following the Council meeting, Site Architecture Studio were engaged to complete the final design documentation and provide costings for the upgrade to the Recreation Centre. Site Architecture having been working very closely with Tess JoynerSlot from JoynerSlot Consulting who has been engaged to assist with the project to tender documentation stage.

A workshop was held with Council on 18 July 2017 to discuss the final design and estimated final costings for the project. Questions and clarifications were sought from Stephen Hart, from Site Architecture Studio.

Funding of \$1,300,000 has been successful from Lotterywest for the Recreation Centre precinct.

The endorsement of these final designs and costings will allow Site Architecture to move forward with preparing the tender documentation. Should the funding application to the BBRF be successful we will be ready to proceed to advertising the tender for the works required for the project.
