
Administration Centre from 8am to 6pm and Kalannie General Store from 9am to 12pm.

A Word from the Shire President

This is a special election required after the sad passing of Cr Noel Mills. Make the effort to vote and have your say.

Dalwallinu Town Hall is 100 years old. On the 24 October 2024 the Shire had a morning tea to celebrate the centenary of the opening of the Dalwallinu Town Hall. It was great to see so many people join us for the morning and enjoy a beautiful spread of savouries, cakes, and scones prepared by the Shire office staff. My thanks for their efforts.

Council has completed two projects recently at the hall - removing the toilets and dressing rooms behind the stage to reduce maintenance and replacing the wooden flooring with concrete.

The hall is now leased to the Badimia Barna Bandi Aboriginal Corporation who are using it as cultural centre. It is in its infancy but it looks great and talking to Daryl Fogarty they have many plans. I thank Badimia Bandi Barna Corporation for allowing us to use their facility to celebrate the 100 year anniversary of the hall.

I was contacted by the ABC recently to comment on the training our volunteer fire fighters have to complete. I urge everybody who can, and who may be called upon to fight a fire, to contact the Shire to commence the training, if they haven't already done so.

There are many benefits of doing the training. Once completed the firefighters are issued with PPE. If you have not completed the training and attend a fire to provide assistance you may be turned away.

Most of the training is done online and does not take too much time to complete.

Bushfire Volunteer Information

Fire Season is here

Bushfire volunteers form an important part of the Shire's emergency service response. The Shire manages Buntine, Dalwallinu, Kalannie, Pithara and Wubin Bushfire Brigades and all the registered bushfire brigade volunteers.

To ensure we keep our volunteers safe and comply with WHS legislation, the Shire has put together basic training procedures for all registered volunteers. This includes WHS induction and basic bushfire awareness courses.

We strongly recommend all current volunteers and any new volunteers to get in touch with the Shire to ensure all inductions, training and PPE is up to date.

Burning Prohibited

We would like to remind you that all burning is prohibited between 1 November to 14 February each year. This includes garden refuse and rubbish and bush/grass fires.

From 15 February to 15 March a restricted burning period will be in

place and you will require a permit to burn. Permits can be obtained from Permit Issuing Officers.

Bushfire Information

A reminder that all firebreaks were to be installed by 1 October. Given the growth of vegetation during winter or spring, early attention will ensure a good result and reduce potential fire hazards.

FIREBREAKS MUST NOT BE LESS THAN TWO POINT FOUR METRES (2.4) IN WIDTH FIREBREAKS MUST BE INSTALLED AND MAINTAINED AND CLEARED OF FLAMMABLE MATERIAL UP TO AND INCLUDING 1 APRIL.

THE PURPOSE OF FIREBREAKS IS TO STOP FIRE SPREADING, TO ALLOW ENTRY FOR FIRE FIGHTING VEHICLES AND TO PROVIDE A BREAK FROM WHICH BACK BURNING CAN TAKE PLACE TO CONTROL A FIRE.

Penalties

Failure to comply with the Bush Fire Act 1954 can result in fines ranging from \$100 to \$25,000 or imprisonment.

Permits

How to Obtain Permits

Burning permits can be obtained from a Fire Control Officer. When applying for a permit you will need to provide the Lot Number and Street Name of the property for which the permit is to apply.

PLEASE REMEMBER TO INFORM THE SHIRE PRIOR TO BURNING

When to Obtain Permits

Permits are required for burning bush and grass at any time between 1 - 31 October and 15 February - 15 March in all areas. No burning is allowed between 1 November - 14 February.

The Shire would like to request that Ratepayers consider the electronic options they now have available for ease of receipt of all notices from the Shire. There are many options for you to consider when either contacting or receiving information from the Shire. Some shortcuts have links on the front page of the website.

We encourage all ratepayers to register for E-Rates now. This facility will ensure that you should never miss receiving your information even if you move house and forget to update your details with the Shire.

Change of Details /Address form

Use the Change of Details form to notify the Shire of a change of address, name or property details. It is important that the Shire has your correct details. Failure to do so may result in very important correspondence not getting to you e.g. your annual rate notice. Report It function

Online Form – Registration for E-Rates now active

Council have established an E-Rates online registration form.

We encourage all ratepayers to enrol for E-Rates.

This will eliminate any loss or missing rates notices.

Benefits of E-Rates

- Quicker way to receive your annual rates notices (final notices and instalments are not available via eRates)
- Ease while travelling for a long time, on holiday or living overseas.
- You still get your notice if you have moved and forgot to update your postal address.

Things to be aware of before applying:

- If you are not the Owner or Agent for the Property, you are not eligible to register.
- There can only be ONE email address for each notice.
- If there is more than one owner of the property and other owner/s apply to receive an electronic notice, the eRates system will by default send the notice to the last registered email address.
- Once the registration is processed by the rates officer, you will receive a confirmation email.

Are you eligible for a Rates Concession?

If you hold one of the following concession cards, own and occupy a rated property within the Shire you may be eligible for a concession on your annual rates. Not applicable to properties used for commercial purposes including rural properties.

- **Pensioner Concession Card**
- State Concession Card
- Commonwealth Seniors Health Card together with a WA Seniors Card or
- WA Seniors Card

Registration is not done through the Shire of Dalwallinu but with the Water Corporation. To apply contact the Water Corporation on 1300 659 951 or complete the registration form available at http://www.watercorporation.com.au/Bill-and-account/Apply-for-a-concession

The Water Corporation will notify the Shire of Dalwallinu. Rates must be paid in full prior to 30 June of the rating year to receive the concession. Unsure if you already claim the concession? If you are already claiming the concession it will show as "State Government Rebate Allowed" on your Annual Rates Notice.
